Town Board Meeting May 19th, 2025 Minutes

The May 19th, 2025 Sugar Creek Town Board meeting was called to order at 6:30p.m., at the Town Hall, by Chairman – David Robers.

All open meeting laws have been complied with for this meeting.

Approval of Minutes: Supervisor – Jamie Morin made a motion to approve the April 21st, 2025 minutes as presented. Supervisor - David Clarbour second the motion. Motion carried unanimously.

<u>Treasurer's Report:</u> \$1,496,786.97 in cash assets as of May 19th, 2025 per Clerk – Sara Morin.

<u>Approval of Bills:</u> Supervisor - David Clarbour made a motion to approve as presented. Chairman – David Robers seconded the motion. Motion carried unanimously.

<u>Road Report:</u> Road Supervisor – Greg Walbrandt he's been cleaning up Millard Cemetery, working on the roads, and will be clearing dead trees. He's been prepping the lawn mower for the ditches.

Retail sales related to
